The Internal Quality Assurance Cell in its very first meeting in the academic session 2014-15 created a Research Promotion Committee (RPC) on 25th June 2014 and passed a resolution to formulate a code of ethics to check malpractices and plagiarism in research so that any kind of misconduct in the field of academic writing can be prevented. It is the prime responsibility of the RPC to distinguish between original and plagiarized work.

- 1. The teaching faculties and students should submit their research papers to the RPC.
- 2. The RPC should check the research papers for by putting the data in one of the following free online softwares:
 - a) https://www.duplichecker.com
 - b) https://searchenginereports.net/plagiarism-checker
 - c) https://www.copyscape.com/plagiarism.php
 - d) www.plagramme.com
- 3. The RPC should recommend publication of the research papers if they are in order and not more than 10% plagiarism is found.
- 4. The RPC should ask the researchers to modify and resubmit their papers if the above criteria are not fulfilled.
